# INFORMATION ON THE PROCESSING OF PERSONAL DATA OF PARTICIPANTS IN EVENTS Information about sports results management

Based on the consent of the data subject pursuant to Art. 6 (1) (a) DSGVO or the fulfilment of a contractual or legal obligation of the data controller pursuant to Art. 6 (1) (b) and (c) or (f) DSGVO, the personal data of the data subject, insofar as they are necessary for performance/results recording or results management in connection with registration for or participation in (sporting) events or competitions and also stored and made publicly accessible in accordance with Art. 17 (3) in conjunction with Art. 89 DSGVO for archiving purposes in the public interest and legitimate interests of the controller.

Information about sound and image recordings

The participant acknowledges that audio and video recordings will be made at the events for journalistic purposes in accordance with § 9 of the Austrian Data Protection Act, and that these recordings will subsequently be used (television and radio broadcasts, photos, video, audio, etc.). The participant acknowledges that recordings of him/her during or in connection with the event may be stored, evaluated and also exploited for commercial purposes by the organiser and/or other authorised persons (e.g. television broadcasters) without compensation, without any time or space restriction, by means of any current or future technical procedure, provided that the use does not unduly infringe his/her personal interests.

#### **INSURANCE**

Liability insurance will be taken out on the part of the organiser.

Participating teams are responsible for their own insurance requirements for travel, personal accident, liability and medical matters for the duration of the Championships. Accident insurance including race risk and recovery costs.
